Appointments to the MPAC reflects the proportional representation of political parties in Council & does not exceed 13 members.

To review and evaluate the content of the Annual Report and make recommendations to Council.

To examine the Financial Statements & Audit Reports of the Municipality.

To promote good governance, transparency and accountability and value for money in the use of Municipal resources.

To recommend or undertake any investigation in its area of responsibility, after reviewing any investigation report.

Did you know?

MPAC is a Committee of Council established in terms of Section 79 (1) (a) and (b) of the Municipal structures Act of 1998.

Shall not perform functions that of an Executive nature or fall with the ambit of management.

Reports directly to Council via the office of the Speaker.

Has the right to call the Accounting officer or other senior staff to provide information or clarity on any matter of financial governance.

May request support of both the Audit Committee and the Internal Auditor / Audit Unit.

May engage directly with the public and respond to public comments and concerns that fall within its ambit of responsibility.

MPAC Reporting

- ♦ In its performance report to Council, MPAC shall deal with the following:
- ♦ Activities of the committee over the preceding and current financial years.
- ♦ The number of meetings held.
- ♦ The membership of the committee and any measures to retain skills and experience / ensure continuity.
- ♦ Key resolutions taken on the Annual Report.
- ♦ Shall report to council not less than once per quarter. In the case of financial and budgetary performance oversight reports, it shall report on: Recommendations to council, council resolution on the recommendations.

MPAC Self-Monitoring & Monitoring of Council Actions:

It shall develop a monitoring mechanism and tracking mechanism that is aligned to its approved work programme., this includes:

- ♦ A record of the recommendations made to Council, the date and nature of the Council response or resolution;
- ♦ The key respondents in the matter and expected action;
- ♦ The outcome of the recommendation implemented / not implemented and any pertinent reason for not implementing;
- ♦ The self monitoring framework used by the MPAC should reflect the measures set out in its own performance report to Council.



Monitoring of MPAC by Council

- ♦ Council must evaluate the performance of MPAC on an annual basis; and
- ♦ The performance measures used for this process shall reflect the measures set out in the MPACs own performance assessment report to Council.

The MPAC Terms of Reference may be used as follows;

- ♦ In MPAC interactions with senior Politicians and Directors to explain the role of the MPAC and the expectation of senior Politicians and Directors.
- ♦ To identify key priorities from the NDP / Medium Term Strategic Framework and the State of the Province address.
