## PENALTIES FOR ERECTING A BOUNDA-RY WALL WITHOUT THE APPROVAL OF THE MUNICIPALITY:

- Any person found guilty of a contravention of these by -laws shall be guilty of an offence and liable on conviction to a fine not exceeding R 4 500.00.
- In failure to comply with the above requirements shall lead to imprisonment for a period not less than 3 months.
- If such person proceeds with the offence the Council may institute legal proceeding against the transgressor with application for demolition order of such boundary wall or fence.



## ONCE MY PLANS ARE PASSED, CAN I START BUILDING:

**Yes,** but commencement fees to be paid to the municipality to ensure building gets inspected on all stages by the building inspector from Foundation, walls, Roofing, Finishes and Completion Stages.

**Owner, Contractor responsible** for inviting Building inspector on all stages of inspection.

**Building inspections** are carried by Building Inspectors to ensure that plans have been followed during construction and to ensure safety precaution are followed during construction.


### **CONSULT YOUR MUNICIPALITY**



### KNOWING ABOUT THE ENVIRONMENT:

- Do not build inside flood line (a flood line is an area where flooding can occur during heavy rains).
- Do not build on swamps or wetlands (a swamp or wetland is an area water logged).
- Do not build within 50m from a river.
- Do not build in environmentally sensitive areas (Steep slopes or where the ground is eroded).
- Do not build closer or below electricity over headlines, electrical substation or electricity boxes.
- Do not build below mountain cliff
- Do not build where you cannot access the area by car.

#### WHAT ARE BUILDING PLANS?

A building plan is a drawing that shows what a building will looks like after being built. **Building plans are drawn by Professional Registered Architect or Draughts person**. Building plans are also used to **calculate** how much the building will **cost to build**.


#### WHEN WOULD I NEED THE BUILDING PLAN FOR YOUR BOUNDARY WALL?

You need a building plan when your boundary:

- a) Alteration on boundary walls **exceeding 1,8m**, make or cause
- b) Palisade fencing exceeding 1,8m height
- c) Electrified fence, electrified railing or other electrified barrier
- d) Demolition of such boundary line



#### WHY DO I NEED COUNCIL APPROVAL TO BUILD AND DEMOLISH ON MY PROPERTY



- To regulate and control construction of all boundary fencing with in the jurisdiction of local authority
- To control boundary access gates
- To prohibit encroachments of municipal land by erecting fencing



#### WHAT DOCUMENTS MUST I SUBMIT FOR BOUNDARY WALL APPROVAL APPLICATION?



- a) You need **4 x copies, with 1 x set in colour. Site Plans** (with dimensions of boundary) sections and elevations of proposed boundary.
- b) Complete submission forms. Forms obtainable from Municipality (Munitata Building, Mthatha)
- c) Proof of land ownership, SG Diagram and rezoning certificates.
- d) For Structural Work, a registered persons form needs to be completed and submitted by an register engineer. Structural drawings to accompany the submission of the boundary wall

# HOW LONG DOES IT TAKE THE MUNICIPALITY TO APPROVE BUILDING PLANS

- a) The municipality approves building plans within 30
  Calendar days where no remarks are raised from scrutiny processes.
- Where remarks had been addressed for correction by owners or architect the process takes 90 Calendar Day.
- c) Where remarks are not attended for correction by the property owner or architects the Building Plan will not be approved. Process start from beginning in case of plans not approved.

# ENFORCEMENT OF BOUNDARY WALL REGULATIONS:

#### No person may-

- a) Build, erect boundary wall **exceeding 1,8m** high without obtaining council approval.
- b) Fence and encroach on municipality land.
- c) A person who wishes to obtain the consent of the Council must submit an application form similar to the form to the Council,
- e) Should the Council refuse permission shall be communicated in writing with the reasons for the refusal.
- A person who has obtained consent to erect boundary wall may apply for commencement when ready to start construction.
- g) An inspector shall be designated to ensure all minimal standards are adhered to during construction of such boundary wall.
- h) May erect or cause to be erected a fence covered with-
  - canvas, reeds, grass or any combustible material, except poles or split poles, or approved wood, which may not be erected within 4,5 m of any street and which may **not exceed 1,8 m** in height above natural ground level; or
  - sheet iron, corrugated galvanized iron or any other sheeting along or **within 4,5 m** of any street etc,
